The Indian Institute of Information Technology (IIT) Sonepat invites Expressions of Interest (EoI) from eligible parties for design, development and maintenance of IIIT Sonepat website. This EoI is meant to select firms/companies/bidders which will be eligible to submit full-fledged technical and commercial bids at a later date for the design, development and maintenance of IIIT Sonepat website. However, this is a "Non-committal" EoI as per GFR 2017.

#### A. General Instructions

Eligibility Criteria to submit EoI:

- (i) The agency/firm/bidder should be a registered body under Indian laws (proof to be attached).
- (ii) The agency/firm /bidder should have minimum of 05 years of experience of professional web site development (attach purchase orders, work-orders etc. as proof).
- (iii) The agency/ firm/ bidder should have experience of working on cross platforms and must have developed websites for at least 03 reputed Industry/educational institutes. (attach purchase orders, work-orders etc. as proof).
- (iv) Average annual turn-over of the firm must be more than 10 Lakhs in the last three financial years (proof to be attached).
- (v) The agency/firm /bidder must have GST registration (attach GST registration certificate).
- (vi) The agency/ firm should have been registered at least 5 year prior to the last date of closing this EoI.

#### **Essential Competencies & Experience:**

- (i) Past experience in creating and maintaining professional and exceptionally creative websites
- (ii) Strong editorial team with communications skills to write clearly and compellingly in English and Hindi.
- (iii) Ability to juggle priorities and deadlines and perform well under pressure.
- (iv) Awareness on the latest technologies for website design, development and maintenance.
- The Director, IIIT Sonepat, reserves the right to modify contents of this Invitation for EoI or withdraw it completely at any point in time, without assigning any reason.

### B. Criteria for Evaluation of EoI

All bidders who meet the eligibility criteria will be evaluated based on the table below. IIIT Sonepat reserves the right to invite only a few bidders for a presentation as the next round of evaluation of EoI.
